Issue: FY 2020 Maryland Victims of Crime (MVOC) Program Grant Application and Acceptance of Award

Background: The Victim Witness Unit of the Carroll County State's Attorney's Office (SAO) provides victims and witnesses of crime vital communications such as case notifications and also serves as the liaison between prosecutors for the Circuit, District and Juvenile Courts. The Unit currently consists of two, full-time advocates and one part-time, contractual advocate. The SAO received \$18,000 in MVOC grant funding for FY 2018 as well as for FY 2019 to add the part-time advocate position needed to provide services for an increased number of cases.

In 2018, there were 1,668 active cases in the Circuit Court; 5,688 active cases in the District Court and 161 active cases in the Juvenile Court. This represents an increase from 2016. More than 60% of cases require the services of the Victim Witness Unit. Currently, of this 60%, approximately 20% are receiving only indirect service. These cases often involve multiple victims with special needs, large numbers of witnesses, and complicated restitution figures. Additionally, the new Maryland Electronic Court (MDEC) procedures have impacted the workload that the advocates currently carry. Therefore, the SAO is seeking to change the status of the part-time, contractual position to full-time, grant contingent. A full-time position would support the increased workload and allow for a more proactive approach in making sure victims understand their rights and are aware of all of the available resources.

The grant funds will support the position's salary and 30% of the benefits. There is possibility of a second year of level funding for FY 2021 provided the program is in good standing.

Issue:

Feasibility study for an indoor dome facility at the former North Carroll High School

Background:

In 2016, as a result of declining enrollments, the Carroll County Board of Education made a difficult decision to close three schools. North Carroll High School was one of the schools that closed. Since that time the school has remained mostly vacant and continues to cost the County through annual maintenance fees. The gym and fields continue to be used by the local recreation council.

Turf fields have become the "norm" for nearly all outdoor sports. All surrounding jurisdictions have turf fields which are used for local sports teams. Some also host tournaments and other special events which produce revenue. A turf field, with the bonus of a protective dome, would be especially attractive for growing our local-based recreational programs as well as attracting sports competitions/tournaments that would generate positive economic and fiscal impacts to the County.

Request the Board of Commissioners authorize the issuing of a Request for Proposal (RFP) for a marketing feasibility study to ascertain the demand and economic impact of such a facility in Carroll County.

Issue:

Discuss pursuing litigation against leading opioid manufacturers.

Background:

Hundreds of municipal and county governments nationwide, including numerous municipalities and nine counties in Maryland, are currently pursuing litigation against leading opioid manufacturers to recover the governments' medical, public health, and law enforcement costs related to opioid abuse. The lawsuits against manufacturers (and in some cases providers) allege that the opioid addiction crisis stems from the over-promotion, sale, and distribution of prescription opioid medications such as Oxycontin and Percocet.

Suits filed in federal court have been consolidated and assigned to a single United States District Court Judge in Ohio. Other cases have been filed in the state courts, bypassing the federal consolidated litigation. Typically, counties and cities engage outside counsel to initiate and pursue the litigation against the manufacturers and providers of the drugs. The attorneys work on a "contingent fee" basis, meaning that payment to the attorney for legal services and costs depends upon there being some sort of recovery or award in the case.

Action:

Consider whether to explore initiating or joining in litigation against the opioid manufacturers and distributers?

Background:

The Bureau of Resource Management (BRM) is seeking \$1,325,000 from the Maryland Water Quality Financing Administration Bay Restoration Fund Wastewater Program to fund a program of stormwater management retrofit projects to address the requirements of the County's National Pollutant Discharge Elimination System (NPDES) Permit. The BRM is in the planning and design stages for Brynwood, Melstone Valley, and Windsong Estates stormwater retrofit projects. These projects are located in predominantly residential areas and include over 400 acres of drainage area, including over 60 acres of impervious area that will be treated by the proposed facilities.
